# U.S. Office of Management and Budget's Statistical Policy Directive No. 15: Standards for Maintaining, Collecting, and Presenting Federal Data on Race and Ethnicity

First update to SPD 15 since 1997 Federal Agencies must comply by 2029

## Sexual Orientation and Gender Identity

- "Some 7% of Americans are lesbian, gay or bisexual, according to a Pew Research Center survey of 12,147 U.S. adults conducted in summer 2022."
- "Some 1.6% of U.S. adults are transgender or nonbinary that is, their gender differs from the sex they were assigned at birth." according to survey of U.S. adults in May of 2022.
  - 5.1% of Young Adults 18-29 are transgender or binary.


According to Census Bureau director Robert Santos, "Other federal agencies have identified uses for SOGI information, such as for civil rights and equal employment enforcement."

# **Census Citizenship Question**



Not the Trump Administration

Page 680

"Add a citizenship question"

"Any successful conservative Administration must include a citizenship question in the census."

"By law, the Census Bureau must deliver the decennial census subjects/ topics to Congress three years before Census Day (in this case, by April 1, 2027). Questions must be presented to Congress two years before Census Day (April 1, 2028)."



## Political Appointees at the Census Bureau

"The department clearly needs far more political leadership, including at the Census Bureau."

"Strong political leadership is needed to increase efficiency and align the Census Bureau's mission with conservative principles...This will require the Office of Personnel Management to allocate additional political appointee positions to the Census Bureau."

"The purpose is to help explain why specific questions on the ACS are asked, which estimates are created from the answers to these questions, and how federal agencies and other organizations use these estimates"

Information requested from the federal agencies included:

- □ a clear explanation of each use of ACS estimates
- □ any applicable legal requirements for their uses
- ☐ the **geographic levels** at which the estimates are used
- ☐ the **specific questions necessary** to accomplish each use
- □ whether alternative data sources can be utilized.




- Slower growth compared with previous projections

# Congressional Budget Office Projections


### **CBO**

- "As growth of the population age 65 or older outpaces growth of younger age groups, **the population continues to become older,** on average."
- •Population growth generally slows over the next 30 years, from 0.6 percent per year, on average, between 2024 and 2034 to 0.2 percent per year, on average, between 2045 and 2054
- •Net immigration increasingly drives population growth and accounts for all population growth beginning in 2040, in part because fertility rates remain below the rate that would be required for a generation to replace itself in the absence of immigration.

## **CBO** Net International Migration

#### Net Immigration

#### Millions of people




CBO estimates that net immigration to the United States was 2.6 million in 2022 and 3.3 million in 2023. Those estimates are larger than net immigration from 2010 to 2019, which averaged 900,000 people per year.

The agency projects that, on net, the number of people immigrating to the United States will be 3.3 million in 2024, 2.6 million in 2025, 1.8 million in 2026, and will average 1.1 million per year over the 2027–2054 period.



#### CBO's and Other Agencies' Projections of the Population



Largely because of greater estimated net immigration, CBO's projection of the population is higher in the near term than SSA's and the Census Bureau's projections. In later years, CBO's population projection is lower than SSA's projection and the Census Bureau's high immigration scenario.




# University of Virginia Projections 2024-2050

"...we may see the national rate of growth decrease from nearly 10% in 2000-2010 to 7.4% over 2010-2020 to an anticipated 5.5% over 2020-2030.

Most states will also experience similar deceleration as per the projections.




#### Projected Growth Rate State vs. Nation

over 2020-2030, 2030-2040, 2040-2050




## Natural Change (Births minus Deaths) by State 2022



- The Census
  Bureau projects
  that deaths will
  exceed births
  nationally by 2038.
- If the US is to grow, it must be through Net International Migration.



## Domestic Migration by State 2022



- Domestic Migration in New Mexico has been negative since 2012
- Net International Migration currently accounts for all growth in New Mexico

 Net International Migration was positive for all states in 2022
